



**MEMORANDUM OF AGREEMENT
ON STUDENT EXCHANGES**

Between

NATIONAL UNIVERSITY CORPORATION KOCHI UNIVERSITY

and

UNIVERSITAS TANJUNGPURA, INDONESIA

National University Corporation Kochi University, Kochi, Japan, and Tanjungpura University, Pontianak, Indonesia, confirm this Memorandum to promote student exchanges between the two institutions based upon the Agreement on Academic Cooperation, including these fields: Economics, Social Sciences, Teacher Training, Education, Natural Sciences, Engineering, Agriculture, Forestry, Medical Sciences and Regional Collaboration.

1. **Duration of stay**
The duration of stay of the exchange students at the host institution shall last for up to one academic year.
2. **Number of exchange students**
Each institution may send and accept under this exchange program not more than five students per year.
3. **Status of exchange students**
Each institution shall accept the exchange students as non-regular students who do not aim at obtaining a degree from the host institution.
4. **Acceptance procedures**
The home institution shall select the students participating in the exchange program under the terms of this Memorandum initially, and the host institution shall make final admission decisions in each case.
5. **Study program**
The exchange students shall determine their study programs at the host institution in consultation with academic advisors of both home and host institutions. Depending on the study program, language requirements and/or other prerequisites may be imposed.
6. **Academic record and accreditation**
The host institution shall evaluate the academic performance of each exchange

student according to their rules and shall send the academic record/transcript of each student to the home institution. The home institution may give credit to each student according to their regulations.

7. Tuition and other fees

The exchange students shall not pay examination fees, matriculation fees or tuition to their host institution. (Regarding summer school and other intensive sessions, a separate memorandum will be drafted.)

8. Financial responsibility

The exchange students shall take out comprehensive health insurance which is valid in the host institution's country and shall be responsible for their own expenses, including travel expenses, accommodation costs and health care fees.

9. Commencement and duration of the Memorandum

This Memorandum shall come into effect on the date of its signing by the Presidents of both institutions and shall be in place for five years. Either party may, given twelve months written notice to the other party, terminate the Memorandum. In the absence of such an early termination, the two parties shall discuss the renewal of this Memorandum no later than six months prior to the natural termination of the current Memorandum. The terms of this Memorandum may be revised or modified at any time through joint review and recommendation by both parties.

10. Authentic text

The Japanese and English texts of this Memorandum shall be equally authentic.
