MEMORANDUM OF UNDERSTANDING

between

Tanjungpura University, Indonesia

and

University of Leicester, United Kingdom

1. Tanjungpura University and the University of Leicester subscribe to this Memorandum of Understanding in recognition of the mutual benefits accruing to their academic communities from the establishment of strong international links. The purpose of this Memorandum is to promote co-operation between the two institutions.
2. The addresses and contact points for each party are given in the Appendix to this Memorandum.
3. The parties agree to promote and develop co-operation in specified fields of economics, law, politics and social science, teaching and education, engineering, agriculture, forestry, mathematics and natural sciences, and medicine through the following:
 - a) Staff Development
 - b) Degree and Non Degree Training
 - c) Teaching and Learning Technology
 - d) Cultural Exchange Activities
 - e) Materials Development
 - f) Student exchanges
 - g) Double Degrees
 - h) Research Cooperation
 - i) Preparation of scholars predeparture and orientation programme on post arrival
 - j) Organised conferences and seminar
4. Members of staff of the two institutions will be encouraged to consult with each other and to develop specific plans for co-operation.
5. For specific co-operative projects under this Memorandum there shall be appointed co-ordinators at each institution in charge of the operation of activities.
6. In relation to specific projects this Memorandum will be supplemented by additional agreements. Such agreements may be made by formal agreement or by an exchange of correspondence between the partnership coordinators in both universities. In particular, the development of joint academic research and collaboration in teaching will require supplementary agreements to be reached between the departments concerned at each institution.

7. This Memorandum takes effect on the date of its signing by both sides and will remain in force until terminated by either party giving at least six months notice to the other.
